



Clarification on draft MGT-7 uploaded on the website of the Company

I, the undersigned Company Secretary of DIC India Limited (“**Company**”) wish to clarify the following points with respect to draft annual return in form MGT-7 uploaded on the website of the Company:

- a. Post transition of official website of Ministry of Corporate Affairs (“**MCA**”) on v3 portal, e-form MGT-7 has now become a web-based form wherein the e-form should first be filled online and then to be downloaded for affixation of digital signature and filing;
- b. The date of annual general meeting of the Company is **MARCH 23, 2026**, however the form is not accepting any future date and is also not allowing to download the form with blank AGM date, hence in order to fill the relevant date the date of AGM is mentioned as February 27, 2026 i.e., the date on which form was filled after exhausting all possible way out;
- c. Similarly, the e-form is not taking date of board meeting post March 31, 2025, and hence only the dates of board meetings held in the financial year upto March 31, 2025 are mentioned in the notice;
- d. Due to confidentiality reasons, remuneration of directors and KMPs are not disclosed at this stage and shall be made available post dispatch of annual report.

We are in discussion with MCA officials to resolve the issues as stated above and will re-upload the final e-form MGT-7 after filing the same on MCA, post AGM.
